2. List of changes

2.1. Version 2.16.0

Ticket#	Type	Change description
#11526	Implementation	In ePLUS service, the uploading files is improved. With this new implementation the user, in addition to loading a main file, can also upload attachments connected to it. Furthermore, the user can either manually define the metadata of the main file, the documentary unit and the file attached to the main document.
#11697	Implementation	A new checkbox has been added on the creation and editing template page, in order to typify the template to update or enter new signatory registry different from the user who is signing the process. This checkbox is displayed exclusively if the uploaded template (odt or docx) has the markers for updating the personal data: U_CFI, U_COG, U_NOM, U_EMA. If the field is enabled (i.e. set to true), when the user signs the process deriving from this template, the service will automatically insert a new signatory registry with the data entered by the user.
#11701	Implementation	From today the additional data are typed. In the eSIGN company configuration, the enabled user to manage additional data can define them with the type (text, numeric, date, date and time, list, YES/NO field) and any properties. During the signing phase, the service checks the congruence of the entered value with the definition of the additional data, in order to avoid inconsistencies in the database. The service carries out the same check when importing the .csv file into the registry users.
#11702	Implementation	The display of additional data in the register of signatory users is changed. List view has been removed and a page view is introduced. To enter or change a value of an additional data, the user must enter the value in the respective field and click on the top right "Save" button.
#11787	Implementation	Standardized the saving and the display of additional data in date and date-time format.
#11531	Implementation	The correct display of the green check when uploading documents to the ePLUS service has been restored.
#11567	Correction	Speeded up the loading of the template and process creation page. At the same time, the loading of data into the lists is also speeded up.

Ticket#	Type	Change description
#11659	Correction	The modification of user data on the Access Management page of the ePRI service is restored. From now, the user is able to modify some user data at the Organizational Areas level.
#11679	Correction	Fixed the display of possible actions on the notification list for a DIP in the eCON service. The user can now only choose between two options "Do not send" or "Always send". Upon formation of a requested DIP, in the first case no notification is sent to the user, in the second one, a notification email is always sent to the user.
#11705	Correction	The search for the "Creation Date" column is changed from "date" to "date time" for the list of processes on the "Signature Processes" page and for the list of consumptions on the page "Signature report" of the eSIGN service.
#11706	Correction	In all services, the ordering imposed in a list is maintained when navigating through the various pages. However, the correct display of the sorting icon was not maintained. After the fix, besides the sorting of the columns, the sorting icon is always correctly displayed when changing pages.
#11709	Correction	The display of the additional data list in the eSIGN service configuration in case of filled the "metadata" field has been fixed.
#11742	Correction	Fixed the sorting of the "Signature Description" and "Phase Description" columns of the signature detail list in the monitoring page of the eSIGN service.
#11743	Correction	Fixed the lists display of all services after sorting a column.
#11744	Correction	Fixed the sorting of the "Data Group" column in the list of additional data on the eSIGN service configurations page.
#11746	Correction	Fixed the sorting of the "Name", "Surname", "Email" columns of the users' list on the "Access Management" page of the ePLUS service.
#11764	Correction	Fixed the display of the document types list when entering global metadata to documents in the ePLUS service.
#11769	Correction	In the eSIGN service, the display of the field types list for editable fields and additional data has been restored.
#11781	Correction	The display of the signature types list when creating an eSIGN process has been restored.
#11799	Correction	In the ePLUS service, the display of date-time type metadata in the metadata entry form both on the main and attached documents has been fixed.
