## 2. List of changes

#### 2.1. Version 2.17.0

Release date: 16/11/2023

#### 2.1.1. eSIGN Service

Ticket#	Туре	Change description
#10645	New Features	The possibility of entering signatory users with minimal personal data has been introduced in the eSIGN service.  From now, it is possible to save a new signatory user only with the following data: name, surname, email and tax code.  For these signatory users, it is possible to start only processes with a simple or digital signature.
#11588	New Features	A new control has been added when creating an AdES agreement signature acceptance template.  For this type of template, the service prevents the loading of an empty .pdf document.
#11719	New Features	In the eSIGN service, the possibility for the signatory users to reject the sign of documents has been introduced.  The signatory user can reject the request signature by clicking on the button in the refusal section.  By entering the reason for the refusal and confirming it, the signature is rejected.  Rejecting the signature, the entire process is stopped and it has the "Rejected" status in Console.  However, the rejected processes may be restarted at a later time.
#11721	New Features	A new flag has been introduced on the template page to create an AdES acceptance or for entering third party data.  This new check makes attachments mandatory during the signing phase.  In fact, by checking this item, for the processes deriving from these templates, it will not be possible to sign until the requested data and the documents will be entered.  Furthermore, the attached documents will be automatically entered into the register of the signatory user entered.
#11733	New Features	The manual restart of a rejected signature process of the eSIGN service has been implemented.  In the detail page of a rejected process, you can restart it by clicking on the "Restart" button located at the top right of the page.  The new created process will be identical to the previous one, both in the initial phases and in the signatory users, and will be automatically started.

#11779	New Features	The insertion of elements in the list of additional data or editable field has been modified. The separator character between list items is changed from "," (comma) to "#" (pound sign).  With this change, it has been introduced the possibility to insert special characters into the list element such as accented letters, exclamation/question marks, commas, semicolons etc
#11782	New Features	The signatory users entered through processes generated by AdES acceptance templates or third party registry entry, are automatically saved in the eSIGN database at the end of the entire process.
#11802	New Features	In the general section of the signatory user's registry, a new check has been introduced to indicate that the company acquired identity documents but it has not entered them in the service.  By checking this flag, the signatory user who signed the fea will be enabled for the advanced electronic signature even in the absence of an identity document in the registry.
#11805	New Features	A new type of identity document has been introduced: the "Residency permit".  At the same time, the display and management of signatory user's attachments are changed.  To manage attachments there are now two sections: "Identity documents", for the exclusive management of this type of documents, and "Attachments", to allow you to enter and manage of all generic attachments other than identity documents.
#11658	Bug-fixes	The anomalous display both the signature fields and the editable fields of the document in the signing phase has been fixed.  Before the fix, these fields were not displayed in the time period which elapses between the approval of the OTP code and the placing of the required signatures on the document.
#11660	Bug-fixes	The insertion of attachment in case of signing from a mobile phone has been fixed.
#11745	Bug-fixes	A marker validation check has been added when loading a template.  If one or more markers have syntax errors, loading is inhibited by showing the error icon with a descriptive tooltip in order to make corrections easier.
#11797	Bug-fixes	Fixed the signatory users's lists in the processes creation phase and in the groups page: the telephone number information is reported only if it is entered in the registry.
#11820	Bug-fixes	In the eSIGN service, the anomaly that the paper FEA acquisition option was always automatically set and saved to false in the signatory registry has been fixed.
#11829	Bux-fixes	The functionality to save new additional data has been restored in the eSIGN service.
#11842	Bug-fixes	The control that prevents the starting of signature processes with advanced signature for signatory users with a revoked AdES acceptance has been restored.
#11844	Bug-fixes	In the detail page of the signature processes, the positioning of the "restart process" and "Go to the process" buttons has been fixed.
#11845	Bux-fixes	The restart of a third party registry entry process with a group of signatories has been fixed: the data previously entered by the group's users are now correctly re-proposed.

#11848	Bug-fixes	Added new controls on the signature page.  In the case of sending the OTP code, the sending method is now displayed on the signature page: whether via email or via SMS.
#11850	Bug-fixes	The procedure to enter third-party data in the case of a group of signatories has been fixed: a separate registry is introduced for each signatory user at the end of the process.
#11858	Bug-fixes	An error during the import of the .csv file for editing and/or adding signatory users has been fixed.  In the event that the non-mandatory columns of the general register of signatory users are not inserted or filled in, the data previously entered in the Console is deleted.  After the correction, the general registry behaves exactly like the additional data: if a column is not entered or cell is not filled in, the data previously entered in the Console is preserved.
#11859	Bug-fixes	A signing process can be restarted even if the sending action to the ePLUS service on the last phase of the restarted process is different from that saved in the eSIGN configuration.
#11860	Bug-fixes	The display of the attachment insertion mask when signing from a mobile phone has been fixed.
#11868	Bug-fixes	The correct display of the file upload button has been restored in the identity document and attachment insertion form.

#11759	New features	The signature process detail page is modified.  The information regarding the start date of the process has been added to the header.  The "Date of signature" column has been added to the list: it is valued with the date and time of the signing.  Furthermore, the information on the type of signature is no longer shown in a column, but it can be displayed by the icon next to the signature status.  Each type of signature is identified with a different icon: it is in dark green if there is the timestamp, otherwise it is in light green.  The information, however, is also available via tooltip: by positioning on the icon the description of signature is displayed.
#11838	New features	The loading of the list-type fields of additional data or editable fields has been changed The lists are now paginated and therefore the values are not all shown in the list: if a value is not visible you need to search for it using the search box.
#11839	New features	The way of loading lists of additional data or editable fields has changed.  From now the lists are paginated: in case a value is not immediately available visible you need to search in the search box.
#11912	New features	The display of "extra" type markers for additional data in .pdf files inserted in signature processes from templates has been changed.  From now, the display of markers is formatted consistently with the definition of the type of the additional data.
#11881	Bug-fixes	The additional data section in the details of the signatory user's details is now immediately visible when the page loads, like all the other sections.
#11886	Bug-fixes	The correct enabling behaviour for sending FEA information via link has been restored.  The correct behaviour of creating a signature process via template has also been restored.
#11920	Bug-fixes	The selection of preservation rules of a classification scheme has been fixed.
#11953	Bug-fixes	The download of the signatory users's .csv file in case of registry with high cardinals (in the order of 10000) has been optimized.
