#14933	New feature	<p>With the changes made, the eSIGN Desktop application has been configured for signing using a SAM (Secure Access Module) qualified certificate.</p> <p>The user selects the SAM certificate from those available in the list, clicks the "Sign" button on the certificate screen, selects the document to sign, and proceeds with the signing process.</p> <p>The signature approval request will be sent to the Entaksi app.</p> <p>By accessing the app, the user can either approve or reject the request: only in the case of approval will the document be saved as signed.</p>
#15089	New feature	<p>In eSIGN Desktop, it is possible to select automatic or remote certificates to be used for signing.</p> <p>If a user with a RAO or CAO profile had logged into the application, he would have seen all the issued certificates.</p> <p>With the correction made, a user with a RAO or CAO profile no longer sees all the issued certificates.</p>
#15158	New feature	<p>The eSIGN Desktop application, in case of anomalies during the signing process, returns error messages.</p> <p>These messages were not correctly decoded.</p> <p>With the modification made, the error message presentation has been improved, showing the following phrase: "Problem applying the signature to the document <documentname>.</p> <p>Please try again or contact support."</p>
#15412	Bug-fix	<p>During the signing process using a SAM certificate, the eSIGN Desktop application sends a signature request to the Entaksi app.</p> <p>The user can approve or reject the signature.</p> <p>If the user had rejected the signing, the eSIGN Desktop signature request screen was not correctly displayed.</p> <p>The previously described issue has now been fixed.</p>
