2. List of changes

2.1. Version 2.13.0

#11379	Implementation	<p>The management and display of the metadata relating to the classification scheme were introduced in the eCON service.</p> <p>The classification scheme metadata is <code>document:title</code>, <code>document:class</code>, <code>document:subclass</code>.</p> <p>At the same time, the following pages were updated:</p> <ol style="list-style-type: none"> 1. <i>SIP list</i>. The new metadata are shown on the detail page and in the deposit receipt; 2. <i>AIP list</i>. The new metadata are shown in the documentary unit detail page; 3. <i>Search and request documents</i>. The new metadata are shown in the list of metadata to do new searches; 4. <i>Search and document collections</i>. In case of searches with these metadata, they are shown on the detail page; 5. <i>DIP list</i>. If in the criteria of the search there are these metadata, they are shown on the detail page.
#11381	Implementation	<p>The restriction visibility management on the eCON service has been added.</p> <p>When entering the role, it is possible to select a visibility restriction based on the presence of some metadata.</p> <p>The user can see only the documents with the metadata for which he has been enabled.</p>
#11393	Implementation	<p>The "Apply" button to restore the configuration directly on eCON and eDOC has been added on the classification scheme page.</p> <p>The "Apply" button appears only if classification scheme is confirmed.</p>
#11398	Implementation	<p>On the AIP list page, in the left section, an archiving log tree view is added.</p> <p>The archive log can be based on different metadata. The structure of the tree is based on the different metadata decided by the company.</p> <p>By clicking on a node in the tree, the list is consequently filtered.</p> <p>To deselect a node, simply click twice (double click) on it and the list will no longer be filtered.</p> <p>At the same time, the "Year", "Document Type" and "Sectional" columns were removed from the AIPs list and a column "Metadata" is inserted. In this column, there are the metadata on which the archive log is based.</p>
#11406	Implementation	<p>The SIP list monitoring page of all the companies has been added.</p> <p>This page is accessible only to the backoffice user.</p>
#11407	Implementation	<p>The AIP list monitoring page of all the companies has been added.</p> <p>This page is accessible only to the backoffice user.</p>

#11408	Implementation	The DIP list monitoring page of all the companies has been added. This page is accessible only to the backoffice user.
#11420	Implementation	In the footer of the page, after the service version information, the information relating to the version of the APIs used by the service was inserted.
#10408	Correction	General correction of the pages for the English language translation.
#11356	Correction	In order to adapt the writing and the layout to the other pages of the services, the display of the "Configurations" page of the "Company configuration" section of the eSIGN service has been corrected. the display of mandatory fields on the page for adding a new group has been corrected.
#11368	Correction	The display of the master data breadcrumb of the eMAN service has been corrected. In the breadcrumb of the master data detail page there are also the name and the surname of the subjects.
#11374	Correction	In the form for entering users for all services on the "Access Management" page, the check of the email correctness has been introduced.
#11419	Correction	In processes deriving from previously loaded templates, you can no longer: <ul style="list-style-type: none"> 1. modify the description of an editable field by clicking on it in the .pdf file; 2. move the signature fields and the editable fields in the .pdf file by drag and drop.
#11433	Correction	Always set the display of the user's email under his name and surname, even if the email doesn't coincide with the user registered in the system. The display of the settings form has also changed: the user's name has been reported darker in order to make it easier to view.

#11442	Implementation	The eDOC quick link button has been added to the dashboard immediately after the eCON button. The eDOC hotkey has the same functionality as the menu item: by clicking on it, the Alfresco page will open on the main page.
#11349	Correction	The column sorting and global filter of the document list on the AIP detail page has been fixed.
#11388	Correction	The filter by end date and time in columns of type date and time on the SIP, AIP and DIP lists has been fixed.
#11390	Correction	In the case of an unlocked menu, the lists on the left side of the page are now correctly resized.
#11454	Correction	In the role entry form, the filter utility on the lists of the document visibility restrictions for the eDOC service and of the roles for the eSIGN service has been restored.

#11451	Implementation	Added some improvements concerning the management and the entry of tree records. The keys concerning the management of the entire registry have been inserted at the top of the pages. The relevant keys concerning the tree management only have been inserted within the section of the tree. By clicking on "Add Root Node" the "root" nodes of the tree are inserted. By clicking on "Expand" , the entire entered tree is opened and expanded. By clicking on "Collapse" , if the tree is expanded, it is closed and only the root nodes are displayed. To modify or delete a node, click the right mouse button on the node itself and select the item of interest from the drop-down menu. To insert a "child" node, click on the parent node with the right mouse button and select the item of interest. In the event that the tree master data cannot be modified, by clicking with the right mouse button on the node, you can view it but not modify it.
#11462	Implementation	Added the classification scheme code management. When you create a classification scheme, the system assigns it a code that is valorised confirming the classification scheme. This code appears on all payment packages with enhancement of the created classification title. The new metadata is visible on ePLUS, on eCON and in the Deposit Receipt. It is available as search metadata in "Search and request documents" and appears in both searches and DIPs.

#11483	Correction	Standardized the behavior of the AIP list filter in the eCON service from the archival tree node, compared to the filters in the list: even when changing the page, the filter performed by the user remains in memory and it is applied when entering in the page again.
#11505	Correction	Fixed the description display of the "Submit for" field on the package detail page in ePLUS service when its state is not "new".
