This document contains the eCON Console release notes for version 2.14.x.

2. List of changes

2.1. Version 2.14.0

Release date: 19/07/2023

Ticket#	Туре	Change description
#11370	Implementation	The new function of the eSIGN service to save mixed templates has been added. Up to the past version, the service allowed the creation of templates exclusively starting from .odt or .docx file models, with signature fields and previously configured markers inside. From this version, the service allows the creation of templates even with both written and empty .pdf files. In the case of documents in .pdf format, the user can insert, modify and configure signature or editable fields as he wishes. During the creation of a process from the template, unlike the signature and editable fields inserted in the documents in .docx or .odt format, they can be modified, moved and it is also possible to insert new ones. If the template contains empty .pdf documents, these must still be filled with a written .pdf file during the creation of the process.
#11409	Implementation	In the Access Management page of Entaksi's services, it has been inserted the access management section dedicated to the eNSO service. From this section it is now possible to: 1. insert an user with the respective role by clicking on the "Add" button; 2. modify or revoke an user by clicking the respectively buttons in line. The roles available to the user are: 1. Service Administrator: he accesses all service functions including role management; 2. Service User: he accesses all service functions except user management.
#11410	Implementation	In the Access Management page of Entaksi's services, it has been inserted the access management section dedicated to the eLUL service. From this section it is now possible to: 1. insert an user with the respective role by clicking on the "Add" button; 2. modify or revoke an user by clicking the respectively buttons in line. The roles available to the user are: 1. Service Administrator: he accesses all service functions including role management; 2. Service User: he accesses all service functions except user management.

#11411	Implementation	In the Access Management page of Entaksi's services, it has been inserted the access management section dedicated to the eAMB service. From this section it is now possible to:

		The roles available to the user are:
		 Service Administrator: he accesses all service functions including role management; Service User: he accesses all service functions except user management.
#11467	Implementation	On the eSIGN service Configurations page, in the "FEA Configuration" section, in the case of FEA acceptance signature process made by link, the possibility to set its author has been introduced. By entering the requested data and clicking the "Save" button, the author of all FEA processes initiated via the link will be saved in the system. If a precise author is not specified, the author of these processes will be a generic user among those enabled for the service. That author will appear on the process list page.
#11502	Implementation	On the eSIGN service Configurations page, in the "Company Configuration" section, the possibility to configure the classification and document type as mandatory when defining the signature process has been introduced. Ticking the items: 1. "Mandatory classification": the service prevents to start a signing process without having valued this field; 2. "Required document type": the service prevents to start a signing process without having valued this field. The mandatory nature of these two fields is independent of each other: the user can request the mandatory of both, of only one or neither.
#11509	Implementation	In case of modification of the classification scheme node, where it is present, the service opens the tree list automatically on the selected node.
#10235	Correction	When defining an eSIGN service signature process, in case of entering a notification email to a third party user, the possibility of selecting the signatory of the phase has been inhibited.
#11436	Correction	Fixed some incorrect graphical displays in the various services when resizing pages.
#11469	Correction	The saving of a classification scheme node with a code composed of special characters has been managed.
#11514	Correction	In the new Console of the eCON service the possibility to generate a DIP for interoperability has been restored.
#11543	Correction	The display of the template editing page (left section) has been fixed in case of reduction of the visualization of the page.

#11570	Correction	Fixed the display of the "NSO" button in the Services Dashboard. This key is visible to all users, both with a "Service User" role and "Service Administrator" role.

#11576	Correction	The revocation of a company with VAT number different from the CF is now allowed on the New Console.

In case of anomalies on the template, the link is disabled with an alert icon. By hovering on this icon, a descriptive tooltip appears with the error description in order to fix it.
